P3 Announcement The Performance Partnership Pilots' (P3) [Application](#) was announced on November 24, 2014 by the federal government. The [Forum for Youth Investment](#) has developed a [P3 Hub](#) with all of the necessary application information.

The Federal Register announcement states, "The Partnership Pilots (P3) program...will enable up to ten pilot sites to test innovative, outcome-focused strategies to achieve significant improvements in educational, employment, and other key outcomes for disconnected youth using new flexibility to blend existing Federal funds and to seek waivers of Federal funds and to seek waivers 4 of associated program requirements. P3 pilots will receive start-up grants to support ongoing planning, streamlined governance, strengthened data infrastructure, improved coordination, and related activities to help pilots improve outcomes for disconnected youth."



Bipartisan Call for the Use of IDS to Provide More Evidence-based Policies/Programs

"U.S. Senate Budget Committee Chairman Patty Murray (D., Wash.) and U.S. House of



Representatives Budget Committee Chairman Paul Ryan (R., Wisc.) announced the Evidence-Based Policymaking Commission Act of 2014. The bill would establish a 15-member commission to study how best to expand the use of data to evaluate the effectiveness of federal programs and tax expenditures. “Linked data sets are an increasingly important tool in marketing, in business decision making, and most relevant here, in shaping and evaluating public policy initiatives in health care, housing, and social services, among other domains. However, because these data sets often contain identifiable personal information, their creation and use can ignite broad and legitimate public concerns regarding the protection of personal privacy. This essay discusses the tension between using linked data sets to inform policy and the privacy and other concerns that emerge from the use of such data.”
