### CIDI's Disparity Report Utilizes Integrated Data



“The Disparity Report originally emerged as a way to visualize city-wide trends in disparities in the context of the work of New York City’s Young Men’s Initiative (YMI). Since then, the [Center for Innovation through Data Intelligence \(CIDI\)](#) has recognized the importance of expanding this work and developing a resource to understand racial disparities for both men and women across NYC over time. This framework conceptualizes a broader context of young adulthood and integrates data from multiple life stages and experiences into one tool for government agencies and community partners to address racial disparities.” Access the complete [report](#).

“Reducing Psychiatric Hospital Readmissions is an important policy objective because readmissions reflect adverse experiences for patients who are hospitalized and put stress on psychiatric inpatient capacity within the public mental health system. The WA State report examines the experiences of persons discharged from community psychiatric hospitals and evaluation and treatment facilities in Washington State, to help identify strategies that might improve post-discharge patient outcomes.”

“Analyses focus on the following post-discharge outcomes: homelessness, arrests, mortality and psychiatric hospital readmission (including admissions to community psychiatric, evaluation and treatment facility and state hospital settings). Researchers examined 32,999 discharges from community psychiatric hospitals and evaluation and treatment facilities from July 1, 2009 to June 30, 2012, tracking patient outcomes for up to 540 days after discharge.” Access the complete [report](#).

### NNIP 3 year Cross-Site Project Expands the Relevance of IDS

“In 2013, NNIP launched a three-year cross-site project, Connecting People and Place, supported by the [Annie E. Casey Foundation](#) to expand the relevance of integrated data systems (IDS) for local policy, increase access to information in IDS, and connect IDS with data on neighborhoods. The project, completed in spring 2016, connected local NNIP partners, who all work to advance data-driven decision-making in their neighborhoods, with organizations and agencies running IDS.”

## NNIP Report Uses Integrated Data Systems to Understand Chronic Absenteeism



“Understanding how individual and neighborhood factors influence chronic absenteeism is challenging. Looking at multisystem involvement using integrated data systems (IDS) along with data about the neighborhood where a student lives can help explain why students are absent, show the challenges they might face, and reveal what interventions are appropriate.”

“To increase access to information from IDS, in 2013, NNIP launched a three-year cross-site project, Connecting People to Place: Improving Communities through Integrated Data Systems, with the support of the Annie E. Casey Foundation. Locally, each NNIP partner connected its data on neighborhoods to data from an IDS to address a local policy issue.” Access the [full report](#).
