includes proposals to expand the use of wage data. These proposals would help to assess the effectiveness of education and training programs, making sure they are really helping people succeed in the labor market. WDQC supports the legislative change requested in the budget to allow the National Directory of New Hires, which contains wage data collected by states, to be used by federal agencies for evaluating education and training. That legislation was approved by the Senate Finance Committee last year, and hopefully we'll see it introduced again in this Congress."

[HUD Article, *Housing as a Portal to Better Educational and Life Outcomes, Highlights Data Sharing Pilot Project with AIS*](#)

“The recognition that stable, affordable housing is needed to achieve good educational outcomes — and that better educational outcomes are needed for improving the life trajectories of low-income children — provides the ideal mission alignment between affordable housing providers and schools. The recent Summit on Affordable Housing and Education convened by the Council of Large Public Housing Authorities and other nonprofit and philanthropic partners gathered some of the most innovative partnerships in this nexus — those between public housing agencies and school systems. The conversation at the summit and HUD’s work in this area confirmed three key points.”

“Data infrastructure and data sharing agreements. Each of the partnerships discussed the primacy of data and data sharing in its work. Privacy rules, however, can inhibit such sharing, preventing school districts from sharing student records with public housing agencies and limiting the ability to collect data, understand student trends and needs, and measure performance. Formal data agreements are needed, but they are not always simple to establish.”

“This is an area in which federal partners can be helpful. HUD is currently involved in a housing and data matching pilot project (run by [Actionable Intelligence for Social Policy at the University of Pennsylvania](#)) through which HUD used data licensing agreements to provide data on assisted households to six jurisdictions, to be matched with educational data and used by local researchers. This project will shed light on educational

outcomes for children in assisted housing over time, and it also tests the feasibility of partnering between HUD and jurisdictions on data-matching efforts.” Click [here](#) to access the full article.

HUD’s Office of Policy Development and Research (PD&R) now has the Authority to Enter into Data License Agreements with Research Organizations

“Policy Development & Research has the authority to enter into a Data License Agreement with research organizations for the explicit purpose of conducting innovative research projects that inform HUD’s policies and programs. Such licenses are appropriate when (1) important policy-relevant research questions can only be answered by using, among other resources, personally identifiable information in the possession of HUD; (2) the research organization can offer adequate safeguards for the confidentiality of the data if HUD shares the data with that organization; (3) the research organization does not need funding or other resources from HUD to carry out the research project; (4) the research organization will destroy all personally identifiable information received from HUD at the expiration of the license.” Click [here](#) to access more information.

Data-Smart City Solutions: Bridging the Gap between People and Public Services

“The Department of Human Services in Allegheny County, Pennsylvania, which includes the Pittsburgh metropolitan area, began developing its [Data Warehouse](#) in 1999, which was recently updated to include a “client matching



algorithm” designed to help improve human services administration by [assessing clients’ needs](#) and matching them to the appropriate programs. The Data Warehouse currently holds an impressive 15 million client records and can report data in real time, making user analysis far easier than it once was for service administrators.” Click [here](#) to access the full article.
