In this report, researchers from Washington's Department of Social and Health Services use integrated data to examine the mental health treatment needs, psychotropic medication receipt, and substance use treatment need for BEST program participants prior to their enrollment. They also look at employment status, chronic illness indicator, social service use, Medicaid receipt, emergency department use, criminal justice involvement, and

[Researchers in CA Use Linked Administrative Data to Better Understand Child Protection Histories of Young Adults Accessing Homelessness Services](#)

“Childhood maltreatment is associated with a variety of young adult adversities including homelessness. This study used linked administrative records to develop a population-level, epidemiological characterization of the child protection histories of young adults accessing homelessness services. The records of all 17- to 24-year-olds receiving homeless services between 2011 and 2014 in San Francisco County, California (n = 2241) were probabilistically linked to statewide child protective service (CPS) records. Findings document that 50% of young adults accessing homelessness services had been reported for maltreatment at least once during childhood. Targeting services that address past trauma and instability among homeless young adults may be justified given the prevalence of CPS history in this population.” Access the [complete article](#).

“The report contains data from sixteen colleges who participate in the Montana University System data warehouse, as well as two other institutions that submitted data solely for this report. This data was linked with Unemployment Insurance (UI) wage records maintained by the MTDLI, tax data maintained by the Department of Revenue (DOR), and two and ten-year labor market projections produced by MTDLI in conjunction with the U.S. Department of Labor. Linking education and DOR data allowed Montana to get more accurate

graduate employment outcomes than many other states have been able to get for similar reports." Access the [complete report](#).
